



# Military Camp at Loftus









**Tents Overlooking Audley**

#### MUSEUM ANNUAL REPORT

Over the past year the Museum has been involved in many historical exhibitions. Heritage Festival 1999 proved to be a very interesting and informative time with the usual display of artefacts in the Museum as well as a photographic display of the building of the railway line from Sutherland to Cronulla, which was opened on the 16th December 1939.

In October 1999, the Museum was involved in the Grays Point Public School October Fest. An exhibition of photographs of the Sutherland Shire was very well received by the public, with 320 people passing through the class room where they were on display.

In November 1999, the Museum had an exhibition of photographs at the Cronulla Bowling Club celebrating the 60th Anniversary of the building of the Sutherland to Cronulla railway line. The exhibition proved to be very interesting to the Bowling Club members and visitors with 350 people viewing the photographs.

The 16th December, 1999 celebrated the railway line's 60th Anniversary. There were also photographs celebrating the 100th year of the naming of the Village of Gunnamatta, which took place on the 25th November 1899. The entrance to the Museum was transformed into the front end of an old "Red Rattler" train, which the public enjoyed very much.

Australia Day 2000 was celebrated at Menai Marketplace on Saturday 22nd January. This proved to work well, as the area where the photographic exhibition was located had lots of room for the display. There were photos of the pioneer days at Menai, as well as the early days of Cronulla. The exhibition was opened throughout the day with the public showing great interest, with 1304 visitors passing through. Australia Day - 26th January 2000 - the Museum had an exhibition of photographs at the North Cronulla Surf Lifesaving Club. Of the 88 visitors that passed through we had a lot of good comments and often received new historical information, as well as supplying it to the public.

Thank you to the Sutherland Shire Council for their support of the Museum. Thank you to the Committee and Members for their continued help throughout the year.

The Museum continues to be open on the first Saturday of each month from 9:00am to 3:00pm and at other times on request.

## Military Camp at Loftus

#### From page 1

Frank relates his story drawing from the newspapers of the day and eyewitness accounts. His story begins in 1886, at the camp.

#### <u>Easter 1886 - Volunteer Military Activities</u> Began at Loftus Heights

It was the first public revue of the combined New South Wales volunteer forces held in Royal National Park. The Easter weekend of April, 1886 was the first of a number of annual revues held on the newly cleared military land at Loftus Heights. This first revue attracted a large number of visitors and created an enormous problem for the Railway Department.

In the words of the time, a Special Reporter from the Sydney Morning Herald describes the scene, early on the first morning at Loftus Heights, 1886:

## The Easter Encampments. Loftus Heights, Friday.

At 5.30 am. the long-drawn notes of the Artillery trumpet sounding the "Rouse" rang out sharp through the clear morning air, warning all sleepers in camp to arise. The moon is still shining brightly high overhead, while all round the eastern horizon a band of delicate saffron colour above the dusky line of the ocean fades away into the pale blue of the firmament, whence the morning star sheds a soft radiance, all betokening fair weather

Easter Monday, April 26, 1886, saw the first revue of some 3,000 men of the combined NSW volunteer militia from all parts of the State. These volunteer forces consisted of infantry, mounted infantry, cavalry and field artillery.

The trains as soon as emptied ran down to the platform, where the line of railway terminates, returning thence to Sutherland...

.....the next two trains arrived, bringing the whole of the 4th Regiment, who looked clean and well, notwithstanding their long night voyage by sea from Newcastle. At 10 o 'clock the corps from Wagga Wagga, Moss Vale and Mudgee, accompanied by those from Wellington and Molong appearing none the worst for the night spent in the train....

#### (Sydney Morning Herald, April, 24 1886)

This first Military Revue attracted a large number of Sydney citizenry, creating a transport record. The Railway Department ran out of carriages to move the many passengers, resorting to cattle trucks in desperation.

From the advent of Federation (1901) and the formation of the Commonwealth Military Forces, Royal National Park was used by the New South Wales Field Artillery, until just after the outbreak of World War I in 1914, the main area for these activities being "Artillery Hill" above Audley.

The clearing, grassing and forming of the military encampment ground, a costly undertaking, was brought about by the combined efforts of the National Park Trustees and the Government's Casual Labour Board. The contract for clearing the military encampment ground stipulated

...that all good shelter, well-grown and handsome trees ... and other plants of an ornamental nature shall be left. By the end of 1883 some 80 acres had been cleared and finally by 1892 2,000 acres. Even today the results of this early clearing of the site can still be seen in the areas around Farnell Avenue.

In 1886, after the Illawarra Railway had reached Heathcote, a "military railway" branch line, the first of its kind in New South Wales, was built from Loftus Junction to pass through the centre of the camp terminating at National Park Station. The early line followed much the same alignment as it does to-day.

On the present line, the Loftus Tramway Museum runs a regular tram service at weekends and public holidays. The signal box that still stands on the main line opposite the tram crossing at Princes Highway, had its first day of operation on 20 April 1886 for the Easter Camp and Revue.

The area north of Engadine through to Sutherland and east of the Princes Highway, formed roughly the site of the military training camp, and was in use from 1886 until the early 1960's when action was taken to cease military exercises.

#### THE LADY NELSON

While researching aspects of Henry Hacking I noted that he had at one time been first mate on the Lady Nelson. This led me to seek references on that vessel and I soon became immersed in her history.

Late in 1800 the Lady Nelson arrived in the southern waters of Australia to carry out survey work. She was under the command of Lt. James Grant, who, as he travelled east named many points of land, including Cape Northumberland and Mount Gambier. On December 7 of that year his ship became the first vessel to pass through Bass Strait sailing in an easterly direction. Just over three months later, on March 21, 1801, Lt. Grant carried out the first comprehensive survey of Western Port Bay.

The ship was very busy that year carrying Lt. Gov. Patterson on an explorative trip along the Hunter River in June. In November, now under the command of Lt. John Murray, The Lady Nelson was once again sent south towards Australia's southern waters. This became another memorable voyage when on January 5 of the new year [1802] Lt. Murray observed 'an opening in the land that had the appearance of a harbour'. She sailed into Port Phillip Bay on February 15 being the first European ship to do so.

Back in Port Jackson the ship teamed up with another famous vessel and an even more famous captain. On July 22, 1802 the Investigator, under the command of Matthew Flinders, left with the Lady Nelson to explore the waters to Sydney's north. Three months later Flinders ordered the Lady Nelson back to Sydney. It appears that our ship went north again the following year with Henry Hacking as First Mate but her most famous exploit in 1803 was when on September 11, she preceded the Albion into the Derwent River to establish the penal settlement in Van Diemen's Land.

In 1806, the Lady Nelson, now under the command of Lt. Symonds, was absent from Sydney for four months. She was visiting New Zealand but due to severe storms encountered on the way, returned to Sydney via Norfolk Island after a stay of only five days. Her mission was to transport a leading Maori "Chief', Tip-Pa-He, his house and his possessions, to the Bay of Islands. In gratitude many gifts were sent back to the Governor with the Lady Nelson arriving back in Sydney on June 13. A refit and a change of crew saw our ship during the following years take up domestic duties once again, trips to Newcastle and Norfolk Island being amongst these.

Governor Macquarie took up his duties in 1810 and in the following year on November 4, was aboard the Lady Nelson for his first visit to Van Diemen's Land. The ship remained in Tasmania with the Governor and on December 20, sailed with His Excellency aboard from Port Dalrymple up the eastern coastline to Newcastle arriving on New Year's Eve, 1811. In his five days there the Governor inspected cedar camps as well as the lime pits and coal mines.

Two months later the Lady Nelson left Sydney once again. This time she had on board the explorer and surveyor, George Evans, who was to survey Jervis Bay. Evans disembarked at his destination returning overland where he recorded the areas we now know as Nowra, Port Kembla and Wollongong, arriving at Appin on April 15, 1812.

The *Lady Nelson* had now been sailing the southern seas for twelve years and would continue to do so for another twelve. She was there at the forefront of many Australian milestones some of which I have not mentioned, such as being, along with the Prince Regent, the first ship to take a group of convicts and soldiers to found the penal colony of Port Macquarie in 1821.

There were also many tales associated with the vessel such as the deserter Henry Antonis described in the Sydney Gazette as a Black Portuguese, with the warning that anybody harbouring such a dangerous man would suffer under the law.

Or what about the ex-convict deserter who left our ship in New Zealand and was reputed to have married a Maori princess, been kidnapped by a trader and later to have been presented as a Maori prince in India. So what started out as a search for Henry Hacking ended up as a small tribute to a small ship which did a big job. In February, 1825, the Lady Nelson left Melville Island and was set upon by Malay pirates. Both the vessel and her crew were lost forever.

#### SECRETARY'S REPORT

1999 was another year of interesting and stimulating meetings covering varied topics and we had the privilege of listening to many gifted and well-informed speakers.

#### **January**

Members' Night in January was as usual most informative – Doug Perry showed a piece of shale Torbanite - which came from Joadja. This shale had been mined in the last century, to produce kerosene, under very harsh conditions. (This was a very pertinent topic as our May outing was to be to Joadja and the prior knowledge we had of the history of the mine made the trip more interesting.) Mr. John Risebrow displayed a series of photographs he had taken of the Sutherland area which he identified and explained. His photography was excellent.

President Dawn Emerson then spoke on the history- of her husband's family who had lived in the district for many years and were particularly involved in the early growth of the oyster industry in Botany Bay.

#### **February**

In February, our speaker was Mr. George Cotis who spoke to us of the history of Port Hacking - how the terrain had altered - in the 2 million years to 1788 huge physical changes – 1788 to 1990 - human interest in this very productive area - timber, grazing, fishing. We must be mindful of our heritage and consider conservation seriously.

#### March

March was the Annual General Meeting and we were delighted to know that Councillor Dawn Emerson was happy to continue as our President. At this meeting, we were pleased to honour Mr. Jim Cutbush and Mr. Terry McCosker with Life Membership in the Society in recognition of their service.

#### **April**

Mrs. Thelma Deacon was our speaker in April. Mrs. Deacon had written a book on poetry and prose from the coal-mining district particularly in the Helensburgh area and gave us a brief history of the coalmining industry in Australia – first discovery 1797 - of the hardships endured by the miners and their families – very graphic and poignant stories in prose and poetry.

#### May

Mr. Rae McLintock OAM from the Historic Houses Trust was our speaker. He is a volunteer guide with the Trust - usually at Government House. He gave us some very interesting insights into the various Historic Houses under their mantle: - Government House, the Museum of Sydney, Elizabeth Bay House, Rouse Hill, Hyde Park Barracks, Vaucluse House. He showed some slides of Rouse House which had been neglected but now open to the Public - fascinating history of a family. We were very interested as we were to visit Rouse House in July.

#### **June**

We were privileged to have Bruce Baird MP, the member for Cook as our speaker. Mr. Baird had been involved in our successful bid for the Olympic Games and had been Commissioner for Trade in Bonn and New York. He spoke of his childhood in Cronulla - schooldays at Cronulla and Sutherland and said how happy he was to be back in the Shire - and would do all in his power to improve problems such as pollution, traffic difficulties, etc.

#### **July**

Mr. Les Bursill, a member of the Society, introduced us to the Website - we are registered (www.suthshirehistsoc.com.au) and would demonstrate at a future meeting as to how the Bulletin would be viewed.

Then Councillor Anne Field from the Rockdale Council addressed us on the history of the Moorefield's Racecourse. She had an exhibition of photographs and newspaper cuttings which were most interesting. She is also writing a book on the rise and fall of the Racecourse - from 1888 to 1951.

#### **August**

Mr. Bursill was able to come to the August meeting and set-up the Internet and showed how the Bulletin appeared - several pages - and to that point 102 persons had viewed the Bulletin via the Net. He then showed his slides of the axe grinding grooves used by the aboriginal people for thousands of years and found in the Royal National Park. His commentary was most enlightening and he said he would be most happy to take a group of members to view some of these sites on a date to be arranged. The walk to sites is proposed for September 2000, but details and costs are yet to be finalised.

#### **September**

This was an extremely interesting meeting. Mr. Charles Banks and his son, Steve spoke of their experiences in the furniture making-business. They had been involved at Brinsleys. They had a wide knowledge of timbers and the origin - were distressed at the disappearance of red cedar - many of the older houses used red cedar and when demolished, the cedar was often taken to the tip. Many questions asked and answered.

#### October

Mr. Gordon Geering spoke to us of the Boer War - 100 years ago - a War fought because of greed and self-appraisement. 16,000 Australian were involved - N.S.W. Lancers, with a huge loss of life on both sides. The first concentration camps were erected - mostly women and children - no medical services. We all felt saddened at the utter futility of War.

#### **November**

Mr. Mark Mitchell was our speaker in November - he had renovated a very old residence in Matson Crescent, Miranda which had been badly neglected. He showed slides of "before-and after" - a wonderful improvement - turning a derelict cottage into a most attractive home, using heritage methods and materials. Members were most interested and asked many questions.

#### **December**

Our last meeting of the year was held in the School of Arts in Sutherland where we were entertained by a delightful programme of music by "The Choraliers" after which a festive Christmas supper was enjoyed.

We are very fortunate to have Councillor Dawn Emerson as our President; she is a very busy Councillor, on many Committees and we are grateful for her experience and expertise. May I say a sincere thank you to President Dawn and all members of the Executive Committee for their support and co-operation over the past year.

**29th May, 1999 -- Joadja --** This was long promised as a tour, but had to be delayed as the village was opened and closed so many times in past years. I understand it is "up for sale" once again now!!! Being such an historic site it is very sad that there is a possibility that this area could be sold and the remnants of the old mining area and the ingenuity of the arrangements made to take the ore out to Mittagong on its way to processing, could be lost forever.

**24th July, 1999 -- Rouse Hill House and Mambledon Cottage and the old Parramatta Cemetery:** This was a very interesting day and showed us how the historic buildings can be preserved for future generations. The cemetery has been of special interest to this Society for many years because we gave the money to have the grave of Henry Dodd maintained, when there was a special appeal for funds to restore the cemetery -- (he grew the first grain in the country, not for consumption of the settlers, but to obtain seed for the ongoing grain production.)

<u>24-25-26 September</u>, <u>1999 -- Week-end to Kempsey</u>: Regretfully we only had a small group on tour. A number of our members felt they could not sit for such a long journey in coach conditions and apologized for being unable to accompany us.

The members of the Macleay River Historical Society went out of their way to make us welcome and we certainly were shown everywhere possible, both near town and surrounding areas, including Trial Bay Gaol, Smokey Cape Lighthouse and other areas of interest. President Dawn Emerson was the chief librarian and her husband Cliff, the Headmaster of Gladstone school, when they lived in Kempsey for a number of years.

We were appreciative of the letter sent by Sutherland Mayor, Clr. Ken McDonell, to the Kempsey Mayor with greetings and introducing our members. The Mayor, Clr. Peter Mainey and his wife were our guests at dinner as were members of the Macleay River Historical Society. The Mayor of Kempsey acknowledged our Patron's letter and this was read at the November meeting by Clr. Emerson.

We thank our hosts for all our outings and for the time given to make us welcome in the places we visited throughout the year.

### Book Review.

Sutherland Shire. A History to 1939.

Maryanne Larkin, Sutherland History Press (P.O. Box 473, Jannali, NSW), 1998, ISBN 0 646 36239 9; 198 pages with notes, illustrations and index; RRP \$24.95, paperback.

This is a fine history destined to become a classic study of the Sutherland Shire up to the Second World War. Maryanne Larkin's book is the product of meticulous research, particularly in the records of the Holt-Sutherland Company.

Although the major focus of her book is the nineteenth century and the first four decades of the twentieth century she also sheds light on the eighteenth-century history of the shire. Dr Larkin mounts a convincing argument that the shire is indeed named after the Orkney islander Forby Sutherland who died during the visit of the Endeavour in 1770. (This was disputed by Marjorie Hutton Neave who declared in 1970 that 'neither the naming of the old Parish of Sutherland, the township nor the Shire had anything to do with the memory of Forby Sutherland')

In the course of research on the life of the Swedish naturalist Daniel Solander, I thought there was not much I had not read about the Endeavour at Kurnell. Yet Dr Larkin has uncovered some fascinating snippets of Aboriginal oral history passed down to a woman named Biddy Coolman who lived at Kurnell in the 1840's. On my many visits to the Endeavour's watering place, I have often wondered whether Forby Sutherland's grave was ever excavated. The answer appears to be yes, although it was not an intentional archaeological exercise. Dr Larkin quotes Robert Cooper Walker's report on the Holt-Sutherland Estate (1868):

When the holes were sunk for the posts of this yard some years back, part of the skull of a man was found. It is therefore supposed to be the burying place of Sutherland, one of Captain Cook's men, who died soon after he arrived here, and after whom the Estate is named.

Much of the history of Sutherland is the history of a large-scale residential leasehold estate, created in 1881 from 12,000 acres of the 13,000-acre property of Thomas Holt. I cannot help but think of the Holt-Sutherland Estate Land Company Limited as having a strong smell of English feudalism about it; however it did

enable a large number of people to acquire land to live on and work at an affordable price with the option to convert to freehold. The centralised management also offered considerable cohesion. Dr Larkin suggests, however, that one of its most unfortunate legacies is the scarcity of public access and reserves along the Port Hacking and Georges River foreshores. In 1891 the company even made the perverse boast that 'there is not a foot of [water] frontage reserved on the whole of the Estate'.

It is well known that Sutherland Shire evolved with an unusually high proportion of British immigrants. By 1921, 16.2% of shire residents were born in the British Isles compared to 12.4% for New South Wales as a whole. Of the 7,676 residents counted in that year, fewer than 200 were born in continental Europe, North America or Asia. Nevertheless, Dr Larkin chronicles the contributions of a number of immigrants from other corners of the globe.

I was particularly pleased to read the story of Marie [de Clozet] d'Errey whose son Mick Derrey I had the honour to befriend shortly before his death. As Dr Larkin recounts, the Derreys (as they became known) were 'French-speaking immigrants from Mauritius' who were unable to pay the rent on their small house in the inner Sydney suburb of Strawberry Hills and saw the option of leasehold land in Gymea as an attractive alternative. Marie, a sailor's wife, arrived at Sutherland Station with her father and walked to Dent's Creek (near the present Gymea TAFE College). They found it 'slimy and full of weeds' and decided to press on, then crossed Woronora Road (which would become the Kingsway) and finally reached:

"a spot where the creek was crystal clear and ten feet wide. There were waterlilies in the creek and it was surrounded by Christmas bush and waratahs." Marie Derrey knew that this was the place for her".


Despite the beautiful site, Dr Larkin later recounts that Marie Derrey 'was so lonely on her first farm in Gymea that she reputedly sang the Marseillaise in the evenings to keep up her spirits'. No doubt living in a dirt-floored shack with bark roof and hessian walls also took a toll on her spirits! Sutherland Shire's history embraces many such stories of determination and personal fortitude in the face of hardship and isolation. Indeed isolation engendered by the Georges River, Botany Bay, the Pacific Ocean and the wilderness of the Royal National Park helped to give the shire its distinct identity and sense of 'separateness' from the rest of Sydney.

It also reduced the price of land for those with few alternatives for permanent domiciles and attracted those who wanted secluded holiday homes and 'weekenders'. Dr Larkin's canvas is a broad one. She covers the Shire's early

industries, the paths of faith, the development of public transport, the construction of road and railway bridges across the Georges River, politics (including the career of the psychopathic Thomas Ley, MLA), tourism and the shire's symbiotic relationship with the rest of Sydney. Maryanne Larkin is a resident of Sutherland Shire and her book is the scholarly yet very readable product of her Ph.D. research. Now Senior Manuscripts Librarian at the Mitchell Library, her professional experience has not only helped her ground this instant local history in a wide range of historical sources, it has enabled her to embellish it with some charming illustrations from the State Library's collection (including Myles Dunphy's beautiful 1912 watercolour of Wattamolla on the cover). The result is a well-produced and very satisfying book.

**Edward Duyker** 

**Edward Duyker** was born in Melbourne in 1955. He first visited India in 1975-76 and returned twice in 1978-79 to complete what he calls "gruelling fieldwork" for a doctoral dissertation on the Maoist "Naxalite" insurgency. After receiving his. Ph.D. from the University of Melbourne, he worked as an intelligence analyst with the Department of Defence in Canberra. In 1983 he accepted a teaching fellowship at Griffith University in Brisbane. He settled in Sydney as a full-time writer in 1984. Dr Duyker's previous books are: *Mauritian Heritage, Tribal Guerrillas, The Dutch in Australia, Beyond the Dunes* and *Of the Star and the Key*. He is married with two sons and is completing a biography of the 18th century French explorer Marc-Joseph Marion Dufresne.

<u>PUBLIC OFFICER:</u> Delete SHALL HOLD THE COMMON SEAL OF THE COMPANY.

The Public Officer is required to notify the Department of Fair Trading by the prescribed form in the following circumstances:

- i) appointment (within 14 days)
- ii) a change of residential address (within 14 days)

and the Booking Clerk for each member of his/her Committee to enable them to take over the Booking Clerk's duties in the event of the Booking Clerk's absence, as temporary Deputy Booking Clerk. In the event of the Booking Clerk not being available, a trained Deputy Booking Clerk will be appointed from the Excursion Committee. If a suitably trained person is not available, then the Treasurer will carry out these duties.

<u>EXCURSION BOOKING CLERK:</u> will take all monies for the excursions organised by Excursion Officer and will issue tickets accordingly. (See the By-Laws as printed in Bulletin.) He/she will forward total amounts to the Treasurer.



#### **BY-LAWS**

#### 1. FEES:

From 1st December, 2000, the following fees will apply:

#### 2. EXCURSION BOOKING RULES:

1. <u>BOOKINGS</u> are to be made direct with the Booking Officer or a duly deputised booking clerk.

#### (a) Fully Booked Excursion


The Booking Clerk may be able to reallocate the ticket to another person should the excursion be fully booked and there is a waiting list.
